The purpose of SALVESEN LOGISTICA's Information Security Management System is to guarantee the availability, integrity and confidentiality of the information and information systems that support the storage and distribution services of temperature-controlled and ambient food products and the storage and distribution of non-food products, thanks to compliance with the requirements of internationally recognized standards.

SALVESEN LOGISTICA, makes its express commitment to deploy this Information Security Policy by means of the following Statement:

- SALVESEN LOGISTICA, undertakes to develop, implement, maintain and constantly improve strategies and processes to ensure that all our activities
 achieve the highest level of efficiency and security.
- SALVESEN LOGISTICA undertakes to comply with the legal and regulatory requirements applicable to the activity it provides, as well as other requirements subscribed, providing the resources identified as necessary, especially in the area of Information Security and those related to the security risks associated with our storage and distribution operations, and the use of information and technology.
- SALVESEN LOGISTICA shall have the necessary means to communicate the Information Security Management System and ensure its adequacy and validity, guaranteeing the continuous improvement of SALVESEN LOGISTICA's processes and services in the area of Information Security
- SALVESEN LOGÍSTICA shall carry out an information protection process, keeping it confidential, complete and available.
- SALVESEN LOGISTICA shall apply the necessary control measures to reduce the risk, according to the risk analysis performed and the risk levels accepted by the organization
- SALVESEN LOGISTICA will obtain the formal and explicit commitment of suppliers and collaborators through the corresponding contractual clauses regarding Information Security Management, who have the obligation to meet the requirements imposed, attend and communicate any indication that may compromise security.
- SALVESEN LOGISTICA shall ensure the continuity of critical operations for the business.
- SALVESEN LOGISTICA shall provide the appropriate infrastructure and resources to comply with the regulatory requirements related to Information Security.
- SALVESEN LOGISTICA undertakes to comply with and enforce its employees to comply with all legal regulations in force and internal protocols related to Information Security.

This Policy establishes a framework for the establishment and review of our Information Security objectives.

The implementation of this Policy is a fundamental objective of the Management, and it is the responsibility of all employees to comply with it in order to guarantee the confidentiality, integrity, availability and continuous improvement of all processes and information systems.
